Minutes of the Meeting of Leire Parish Council held on Tuesday 8th October 2024 at 7.30pm at the Village Hall

6498 To receive apologies from members of council and accept valid reasons for absence Apologies for absence received from Cllr. Cawley-Rock and District Cllr. Worrall.

6499 Declarations of interest

PUBLIC PARTICIPATION SESSION

6500 To adjourn the meeting for representations from other representatives and members of the public

- Cllr. Pool advised that comments have been received regarding the state of the tree beside Violet's bench on Oak Avenue, it is full of brambles. The Parish Council will report the matter to Platform Housing Group.
- The streetlight on Frolesworth Road has been inspected by Western Power. The cut out has burnt out and due to age of the pole bracket National Grid are unable to put a new one on to repair it. They have advised that a new streetlight is required. If the parish has a new column installed at their cost, National Grid will install a connection to the streetlight at their cost. The quote from E-on to install a new column is £813.35 plus VAT. It was decided not to proceed with a replacement at this time.
- Details of savings accounts to move the Avery Redfern Trust funds into have been circulated to the Parish Council for review.
- The drainage problems on the western side of the railway bridge persists and is awaiting inspection, Cllr. Bannister will ask for an update from the County Council.
- The wooden planter located at The Green is in need or repair or replacement. Cllr. Huckerby will obtain a quote. It was noted that this could be a potential use of the Leire Community Fund.

COUNCIL SESSION

6501 To receive and approve the minutes of the Parish Council meeting held on 9th July 2024

Cllr. Huckerby **proposed** approving the minutes of the meeting held on 9th July 2024 as accurate, Cllr. Morgan **seconded** the proposal.

6502 Matters arising the meeting held on 9th July 2024 that are not included on the agenda

- The replacement bin has been delivered to Cllr. Pool and will be installed by Cllr. Pickering.
- Ed Yates has been commissioned to install a post for the new vehicle activated sign.
- It was noted that it is too early to reduce the height of ash tree as it is still full of leaves. Cllr. Pickering will seek advice on whether the tree needs reducing in height or felled.

6503 Matters arising from District and County Councillor's

- Cllr. Bannister advised that the County Council has been overwhelmed with issues relating to rainfall and flooding across the county on week commencing 23rd September 2024.
- Cllr. Bannister advised that he will chase the County Council for an update on the drainage problems on the railway bridge.
- Cllr. Bannister advised that the County Council have planning permission for 2,750 homes and small scale warehousing on the proposed Lutterworth East site. To raise funds to build the spine road needed for the development they are going to try to apply for large-scale strategic warehousing. Strategic warehousing is excluded from the area in the Local Plan, however, due to pressure on the District Council to deliver housing, they may find an exception.
- Cllr. Bannister advised that the Harborough Community Fund has allocated £10,000.00 for Leire to apply for. Cllr. Pickering suggested that an application could be submitted to resurface the car park at the playing field. Cllr. Pickering will obtain some quotes for the project.
